BE AN ACTIVE PART OF YOUR GOVERNMENT

TIPS FOR COMMUNICATING WITH YOUR LEGISLATIVE REPRESENTATIVES

Every elected official is sensitive to grass-root opinion. Your participation in government should not stop with your vote, but there's an art to communicating with your representative.

- Inform your legislator of your stand on the issues of particular interest to you —briefly and to the point.
- Refer to his position on the issues, if known.
- Thank him when he supports an issue of which you approve.
- Write promptly and plainly; a post card is acceptable.
- DON'T write too often to the same legislator during one session, even on different subjects.
- DON'T begin with "As a citizen and taxpayer," and
- DON'T apologize.
- DON'T write to legislators from another district.
- DON'T be discouraged by special interest lobbies.
People can be a powerful lobby.

YOU MAY VOTE IF YOU ARE:

- a citizen of the U.S. for at least 1 month before the next election;
- a resident of Pennsylvania and your election district for at least 30 days before the next election;

AND

- eighteen (18) years of age on the day of the next election.

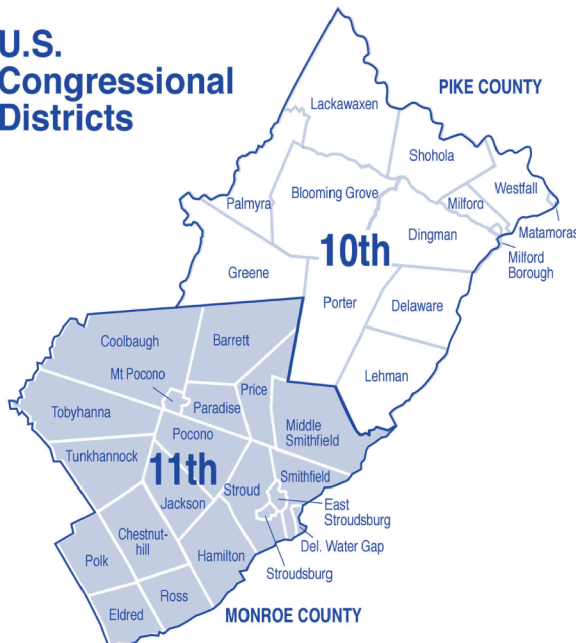

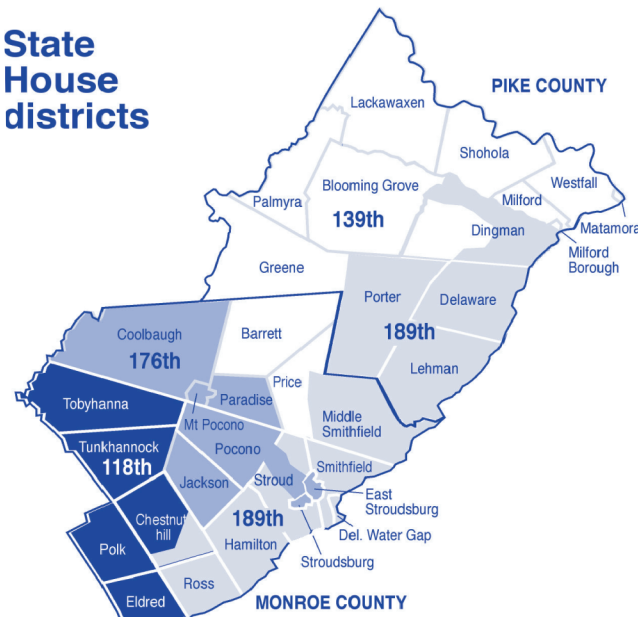

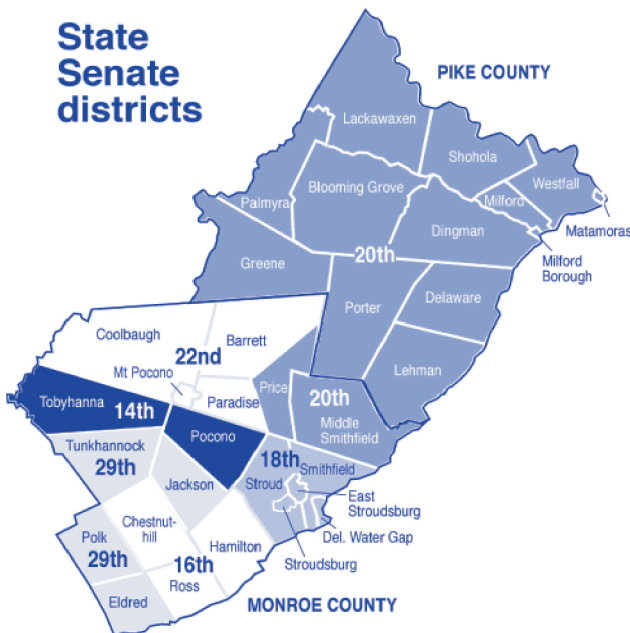
